
WHEREAS, understanding the collective responsibility to cultivate a healthier, educated, and empowered community through collaborative endeavors;

Section II

Scope of Collaboration

The Parties agree to implement cooperation programs including but not limited to:

- 1. Anti-Drug Campaigns: The College's National Service Scheme (NSS) unit will collaborate with the Panchayat to organize and conduct anti-drug campaigns, raising awareness and promoting drug-free communities within the Panchayat.
- 2. Palliative Programmes: Collaborative efforts will be made to support and organize palliative care programs for the benefit of the community.
- Collaboration in Educational Programmes: Both parties agree to collaborate on educational initiatives, workshops, seminars, and other programs that contribute to enhancing educational opportunities within the Panchayat.
- 4. Classes for Kudumbashree Units: The College will provide educational classes and training sessions for the members of Kudumbashree units to enhance their skills and capabilities.

5. Awareness Programmes:

- a. CleanlinessIoint awareness campaigns and initiatives will be organized to promote cleanliness and hygiene practices within the Panchayat.
- b. Health: Collaborative health awareness programs focusing on preventive healthcare, hygiene, and disease awareness will be conducted.
- c. Education: Joint initiatives aimed at promoting education and literacy levels in the Panchayat will be organized.
- d. Sports: Collaborative efforts will be made to organize and support sports events and initiatives to encourage physical fitness and sportsmanship.
- c. Basic Computer/Digital Literacy: The College will conduct workshops and training sessions to promote basic computer and digital literacy among residents of the Panchayat.

Section III

General Provisions

- Both parties agree to allocate resources and manpower as necessary to fulfill the objectives outlined in this MOU.
- Regular meetings will be scheduled to review progress, plan activities, and address any challenges faced during the implementation of joint initiatives.
- Any additional specific terms or changes to this MOU shall be mutually agreed upon in writing by both parties.

SECTION IV

Responsibilities

This responsibilities clause delineates the specific roles and obligations of both Jamia Nadawiyya Training College, Edavanna, and Edavanna Grama Panchayat in ensuring the successful execution of the outlined initiatives.

1. Jamia Nadawiyya Training College, Edavanna:

- a. The College shall designate a liaison officer or a committee responsible for coordinating and overseeing the execution of activities outlined in this MOU.
- b. It will provide necessary resources, expertise, and support for the planning and execution of joint initiatives, including but not limited to personnel, facilities, and educational materials.
- c. The College shall ensure the quality and effectiveness of educational programs, workshops, and training sessions conducted in collaboration with the Panchayat.
- d. The Students clubs shall actively participate in planning and conducting anti-drug campaigns and value education programs, respectively.

2.Edavanna Grama Panchayat:

- a. The Panchayat will designate a representative to liaise with the College and collaborate on organizing and implementing joint initiatives.
- b. It will assist in promoting and facilitating community participation in programs organized by the College, ensuring maximum outreach and impact.
- c. The Panchayat shall provide necessary logistical support, venues, and local resources required for conducting various awareness programs, workshops, and campaigns.

3.Mutual Responsibilities:

- a. Both parties shall work together to publicize and promote joint initiatives through various channels to ensure community awareness and participation.
- b. Regular meetings shall be scheduled to assess progress, address challenges, and plan future activities collaboratively.
- c. Jointly monitor and evaluate the impact of conducted programs and activities for continuous improvement.

Section V

ENTRY INTO FORCE, DURATION AND TERMINATION

- 1. This MOU shall enter into force on the date of signing.
- 2. This MOU shall remain in force for a period of one (1) year and may be extended for another period of one (1) year by mutual written consent of the Parties.
- 3. Either Party may terminate this MOU at any time by giving written notification to theother Party on its intention to terminate this MOU, 30 days prior to the date ofthe termination.
- 4. The termination of this MOU shall not affect the completion of any projects and programs in progress and not completed at the time of termination.

This MOU constitutes an understanding between Jamia Nadawiyya Training College and Edavanna Grama Panchayat, effective from the date of signing by both parties.
